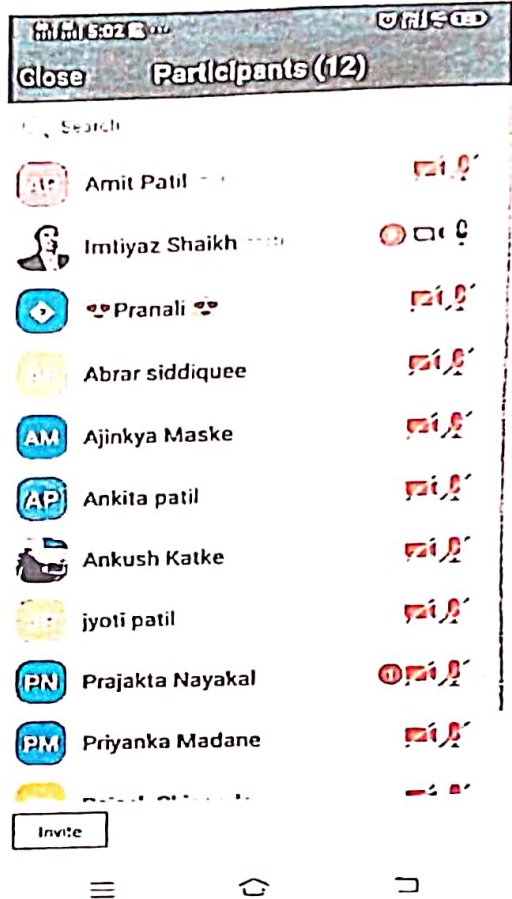
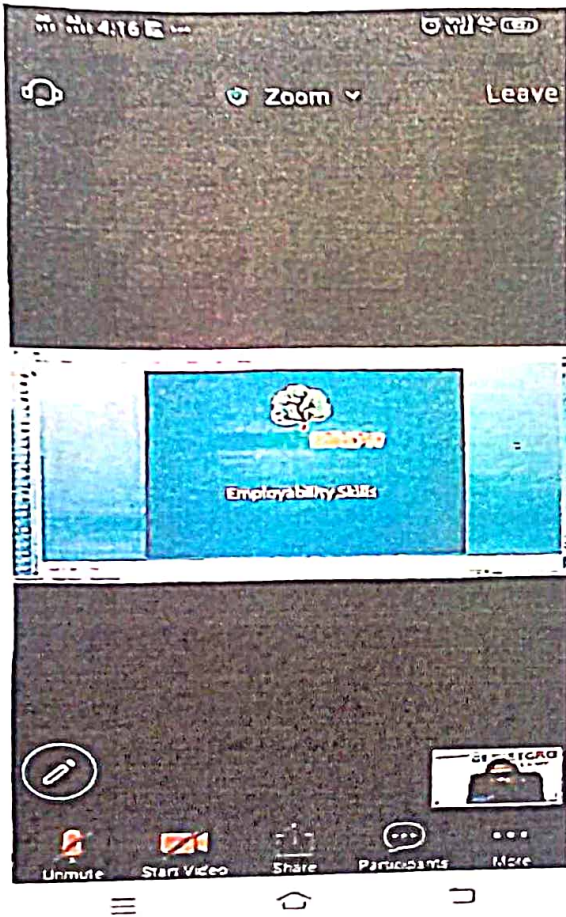
Day two (17-09-2020)
